**BIRZAI VLADAS JAKUBENAS MUSIC SCHOOL'S

REGULATIONS**

**I CHAPTER  
GENERAL REGULATIONS**

1. Birzai Vladas Jakubenas Music school's international pottery exhibition- competition „Fairytale“ (further exhibition-competition) regulations set the aims, tasks, participants, conditions of organization and execution of the exhibition-competition.
2. International exhibition-competition is organized by teachers of Birzai Vladas Jakubenas Music school's department of Arts (further- school) implementing 2020-2022 year school's strategic and 2022 year activity plan.
3. Exhibition- competition partners: Birzai Jurgis Bielinis public library and Birzai district Education Helpdesk.

**II CHAPTER  
GOALS AND OBJECTIVES**

4. The goal of the exhibition-competition is to develop students values, creative initiative, to allow students individualities to be revealed by promoting cooperation between general education and non-formal education institutions for children.
5. Objectives:
  - 5.1 To organize activities encouraging active development and operation, communication and cooperation, sharing of experiences; to present the created products originally and picturesquely to the school's community.
  - 5.2 To encourage teachers of various educational institutions to cooperate according to the model „colleague to the colleague“ model.
  - 5.3 To organize the exhibition-competition, in which students of various educational institutions and different ages are invited to participate

**III CHAPTER  
CONDITIONS OF PARTICIPATION**

6. Participants of the exhibition- competition are students of Lithuanian and foreign educational institutions.
  - 6.1 Works of participants are evaluated according to two age groups.
    - I group - 7-12 years old
    - II group - 13-17 years old

**IV CHAPTER  
PROCEDURE FOR ORGANIZING THE EXHIBITION- COMPETITION**

7. Exhibition-competition is hold since June 2, 2022 till September 9, 2022.
8. Works are presentated and sent till May 23, 2022, 16 o'clock to the adress: Birzai Vladas Jakubenas Music school, Kestucio st. 6, LT-41174, Birzai, (8 450) 32 947, e-mail: [birzai.muzika@gmail.com](mailto:birzai.muzika@gmail.com), website: <http://www.muzikosmokykla.puslapiai.lt>;

9. The submitted work must be accompanied by work metrics of the specified sample (Annex 1)
10. Works of the exhibition will be displayed from June 2, 2022 till September 9, 2022 at Birzai district municipality Jurgis Bielinis public library, children's literature department, at adress: Radvilos st. 3, Birzai.

## **V CHAPTER WORK REQUIREMENTS**

11. The participants of the exhibition- competition submit only spatial ceramic works, which must correspond to the theme and to be fired.
12. Participation in this exhibition-competition is considered to be the consent of the authors to these requirements

## **VI CHAPTER WORK EVALUATION CRITERIA**

13. The exhibition- competition is evaluated by jury set up by order of the director of the School.
14. Only individual works submitted by students are assessed.
15. The evaluation will take into account the originality of the idea, creativity, artistic fulfillment of meaningfulness of the exhibition- competition theme.
16. The winners of the exhibition- competition, the place and time of the awarding will be announced in a separate announcement.

## **VII CHAPTER COPYRIGHT AND PROTECTION OF PERSONAL DATA**

17. By submitting a molding for the exhibition- competition participants take responsibility for its originality.
18. Participants of the exhibition- competition grants exclusive rights for organizers of the exhibition-competition to use their works free of charge for promotion and publicity purposes, including videos of the exhibition- competition being published on the internet.
19. All participants of the exhibition- competition, by submitting their applications and documents (data) and at the same time transmitting personal data of the representatives or participants of the organisation or any physical persons (further- data subjects), confirm that they have informed the data subjects that their data will be transferred to Birzai Vladas Jakubenas Music school, for what purposes and what grounds, have familiarised the data subjects with their rights and informed them that they can find more information about the processing of their data in Birzai Vladas Jakubenas Music School Privacy Policy (<http://www.muzikosmokykla.puslapiai.lt.asmensduomenuapsauga.lt>). When communicating with the data subject, the Birzai Vladas Jakubenas Musical School considers that they are informed about the ongoing processing of their personal data.
20. Personal data provided by data subjects of exhibitors are processed for the purposes of organization, execution (including publication of information on exhibitors, selection of winners and public announcements) and statistics of the exhibition- competition. Controller of the personal data- Organizer of the exhibition- competition Birzai Vladas Jakubenas Musical School.
21. Exhibitors agree that the applications submitted by them and all information about the projects implemented can be used for the purpose of publicizing the exhibition- competition.
22. Personal data of exhibitors and data subjects may be disclosed to the members of the jury. The personal data of exhibitors and data subjects may also be provided to other organizations (partners of the

exhibition- competition), which perform functions directly related to the organization and/or execution of the exhibition- competition, but only in cases and to the extent that such data are necessary.

23. Exhibitors and data subjects, whose personal data are processed for the purposes of organization and execution of the exhibition- competition, have the right to access their data and to know how they are processed, as well as to request rectification, destruction of their personal data or suspension, except for storage, of the processing of their personal data when the data are processed in a manner that does not comply with these provisions or the requirements of laws.
